It also includes 105 minutes in front of school board members, administrators and education leaders from across Nebraska at the 2017 Education Forum held earlier this month in Kearney.

Coach Cook kicked off the morning on what it takes to be a champion. Whether you're dealing with an elite-level college volleyball team, or working to get the most out of your students or staff, it starts with dreaming big, dreaming like a champion.

He discussed the challenges of today's generation. Today's students lack sleep, proper hydration, problem solving, they resort to poor nutrition, and live in a visual world. As he joked, too many glasses of water are being replaced with a caramel macchiato, and all too often, person to person communication is given the back seat to a text message.

Coach Cook shared how he preaches to his teams to make great decisions all the time so you have the confidence to do it when it really matters. Great advice not only for the younger generation, but all of us as we strive to better ourselves each and every day.

He closed the morning address sharing the three items he asks himself daily ... Who needs me today? Would I be chosen again today? Would I want to be coached by me today?

# Beef ... It's What's For School Lunch













Do you know where the food for your last meal came from? Not "the kitchen" or "the store" ... more where did it start. For 46 schools in Nebraska, they know where the beef they're serving their students comes from.

Hundreds descended to Hebron on a beautifully sunny February day for the first "Nebraska Beef in Schools Summit" hosted by Thayer Central Public Schools.

The summit was the idea of Thayer Central Superintendent Drew Harris, and his board to bring together all of those currently serving locally grown Nebraska beef in their schools, as well as those interested in getting a similar program up and running. The summit also included attendees and presenters from the Nebraska Department of Education, Nebraska Cattlemen, Rural Futures Institute, the USDA Farm to School program, NASB, and many more.

Harris opened the morning welcoming everyone to the summit, with the focus that anytime you can incorporate local products and producers into your schools, that is a win-win for both the school and the community.

Rob Marsh, a school board member with Thayer Central feels this program could reach over 100 schools in the next few years, and that one of the key takeaways they have seen with the program goes beyond the lunchroom itself. It is the positive community involvement that comes along with incorporating this program into your schools. It takes a team.

Sharon Davis of the Department of Education spoke to the importance of Farm to School, and how she would love to see this go beyond beef, and eventually incorporate produce, milk, and cheese.

Chuck Schroeder, of the Rural Futures Institute immediately pulled out his phone as he stepped up to speak and snapped a photo of the incredible crowd, "Wow, I need to take a picture to show those in the big city that not everything happens in tall buildings!" He went on to speak on why a program like this is so important to a community. "It's about people coming together around a big idea, no matter the situation, and making it happen. It's about more than the nutrition. This program helps kids learn. Think about their neighbor. It supports community engagement, and the economy of our community."

Following the opening speakers, the morning continued with breakouts on the following focus areas: Food Service Preparation; Livestock Producers; Board Member Roles; and School Administration.

Next were round table discussions on: Recognition and Kickoff Events; Here's the Beef– How do You Attain Your Beef; Educational Component; Championing the Cause, Approaching Producers; Moving Beyond Donation; Marketing Farm to School; A Cut above—Processing, Cuts, and Packaging; Educational Resources; and Beyond Beef—Bringing Fresh Produce to the Plate.

Finally, a presentation on Farm to School from the USDA while lunch was served, and you guessed it, locally grown beef!
