

SNOW CAUSES THE ANNUAL LEGISLATIVE ISSUES **CONFERENCE TO BE SMALL, BUT MIGHTY**

While winter weather kept many at home, including a Senator scheduled to speak, those members who were able to travel to Lincoln for the Legislative Issues Conference were enlightened by Colby Coash's presentation on Sunday evening, and the Monday program packed with Governor Ricketts, and Senators Scheer, Groene, Krist, Stinner and Walz addressing the group.

Former Senator Colby Coash wowed the audience Sunday evening asking them who it is exactly, telling the story of their district. Coash to the audience, "Your word as a board member, should carry weight. It does carry weight." As school board members, you need to be telling your story before others try to tell it for you! He stressed the importance of school board members creating a relationship with their Senator and pointed out that board members are elected to represent their constituents, just like the Senators.

John Spatz opened Monday morning reiterating that Nebraska needs a vision for its future. "Does anyone really run for office saying their number one strategy is to invest in prisons? Yet that's where we are." Spatz went on to say, "I cringe when politicians say the only way forward is cuts. Economic growth is our number one strategy for increasing resources. Invest in it."

Following Spatz, Governor Pete Ricketts addressed the group with a primary focus on taxes, the budget and education. Following the Governor, Speaker Scheer touched on the overall landscape of the session, and his role in leading and managing it these next 40-some days. After the Speaker, Education Committee Chair Mike Groene addressed kev education bills scheduled this session, and took questions from the audience. Senator Krist followed to discuss policy, bills, and the future of Nebraska. In addressing education specifically, he told the

audience, "We can no longer afford to demonize education. Education is an investment in our state's future."

Next up, former school board president and current chair of the Appropriations Committee, John Stinner shed light on the state's current budget situation, and how that will affect various bills. Senator Lynne Walz closed the morning discussing pro-education legislation that she and fellow colleagues, alongside NASB and many other education partners, have worked to introduce this session.

As always, the Legislative Issues Conference concluded with the Lunch with Senators. Again, we thank those Senators and attendees who braved the weather to attend this year's event, but obviously understand all of those who were unable to make it to Lincoln. Based on the twitter activity during the conference, many of you unable to attend were following along online!

When our predecessors gathered a century ago to form NASB, the world was a very different place. Earning a high school diploma was less common, and changing careers was rare. But the mission


