We will travel to your town to see you and other education leaders. We will continue to provide you with money-saving programs, information-sharing services, and events you need to thrive.



## **HISTORY 101: STATE OVERSIGHT OF EDUCATION**

Prior to her election to the State Board of Education in November 2020, Patti Gubbels served on the Norfolk Board of Education, and was a member of the NASB Board of Directors, and the NASB Legislation Committee since 2016.

State oversight of education in Nebraska has a long history. As early as 1869, the Legislature created an office of the State Superintendent of Public Instruction which later (1875) was written into the Nebraska Constitution. In 1952, a Nebraska constitutional amendment established the State Board of Education to have authority over the Nebraska Department of Education. In 1967, the Legislature created eight State Board of Education districts, with one board member elected per district on a non-partisan ballot. That educational governance structure exists today with each district representing an average of 245,000 citizens.



Not all states have state education governance structures like Nebraska. For example, in Washington local school board members elect five of the State Board of Education members. Board members, depending on the state, may be elected via a partisan vote, non-partisan ballot, or be appointed by the governor. Only four states do not have a State Board of Education.

State Senator Joni Albrecht has introduced Constitutional Amendment 24CA which, if passed by a vote of the people, would abolish the Nebraska State Board of Education. The amendment would call for the Governor to appoint the Commissioner of Education who would oversee the work of the State Department of Education. Based on comments in two news sources, Senator Albrecht's rationale for eliminating the State Board of Education is related to dissatisfaction with how the State Board of Education managed proposed Health Education Standards in 2021. It is important to note that the Nebraska State Board of Education took no action related to proposed Health Education standards.

Other proposals to eliminate the Nebraska State Board of Education have been introduced previously by members of the Nebraska Legislature with the most recent coming last year. That proposal did not make it out of the Legislature's Education Committee.

Nebraska's current state education governance structure includes eight members elected on a non-partisan ballot who appoint the Nebraska Commissioner of Education. That structure helps preserve important principles of our representative form of government. Because our State Board of Education members are elected by district, the board represents varied citizen voices about education. The members of the board make decisions to support quality education across the state and answer to the citizens of the district who elected them.

The Nebraska Constitution, Article VII, Section 2 states "...The State Department of Education shall have general supervision and administration of the school system of the state and of such other activities as the Legislature may direct." Article VII, Section 3 of the Nebraska Constitution states that the State Board's "duties and powers shall be prescribed by the Legislature." Our government was founded on the principle of checks and balances to assure that, while each division of the government has some control, no division of government becomes too powerful. The Department of Education is obliged to comply with state laws and to operate within the framework developed by the state Legislature. At the same time, the State Board of Education, as provided in 79-301(2) RRS, "shall be the policy forming, planning and evaluation body for the state school program" and be responsible for providing services to Nebraska schools. The NE Constitution does not give total control for education-related policymaking to either the Legislature or the Nebraska Department of Education.

Constitutional amendment 24CA would reduce representative government and disrupt the checks and balances of state educational governance. The power of citizen voices would be diminished without a Nebraska State Board of Education to represent them. A Commissioner of Education, appointed by the Nebraska Governor, would put education policymaking in political hands. Every time a new governor is elected, the potential would exist for political educational policymaking to whiplash the educational system. Effective state education governance depends on meaningful collaboration of the Nebraska State Board of Education and Commissioner with other education policy makers including the Legislature and Nebraska stakeholders.

The goal of the NASB Policy Customization Service is to create a completed, customized policy manual (in hard copies and electronic format) with legal referencing and indexing that reflects in writing how your individual district actually operates.


We will evaluate a district's existing board policy manual, check for consistency and provide your board with a "road map" of expectations for the governance of your district. Your district has its own unique history and, over the years, has chosen to make different operating decisions than your neighboring districts. We will rewrite your existing board policy manual, keeping the decisions of your board in place, not throwing them out to be replaced by a generic set of policies.



Through this process we will be able to highlight the areas that are presently omitted and add the policies that most experienced boards and administrators believe are necessary for setting out the basic expectations for the operation and governance of your district. When these new policies are brought into your reorganized and updated manual, they are reviewed with your administrators and board policy committee to ensure the language and intent is appropriate to your local needs.

NASB wants your policies to be clearly written and easily understood by the people using them. Many Board Policy Manuals contain policies that are overly detailed, redundant, and confusing. If your School Board is using a Policy Manual that is disorganized, poorly written and difficult to understand, our manual customization process can correct that for you. This is a time intensive process on our part, but the result is to make your manual easier to use, clearer to follow, and simpler to update in future years. #### ... POLICY

Following a two-year decline in vaping among teens, the use of vaping devices is now returning to near pre-pandemic levels. Vape users inhale ultrafine particles along with unregistered and untested chemical flavorants, not to mention the frequent presence of heavy metals such as nickel, tin, and lead. Chest x-rays of young vape users sometimes show significant oily residues already coating their lungs. Your district's Tobacco Free Schools policy should have clear language regarding the prohibition of nicotine products, vapor products, and e-cigarettes. This language should also be included in your Student Handbook.

### ... DATA ANALYTICS

It can be discouraging to see student enrollment numbers at rural districts that have declined by a fourth or a third over the last decade. If this is happening in your district, your board should begin planning now to deal with the demographic changes and consider the implications for the future of your district. NASB can help with an analysis of enrollment trends, test scores, and the condition of existing facilities to assist your board in holding productive discussions about the best options for your district to deliver a quality education in a changing environment.
