LR 335 - ENCOURAGE POSTSECONDARY EDUCATIONAL INSTITUTIONS TO ADOPT THE SEVENTY PERCENT ATTAINMENT GOAL

Introduced by the Education Committee: Walz, 15, Chairperson; Day, 49; Linehan, 39; McKinney, 11; Morfeld, 46; Murman, 38; Pansing Brooks, 28; Sanders, 45.

The Education Committee and education leaders held a press conference on Wednesday, March 16, to highlight Nebraska's proposed educational attainment goals and how the education sectors in the state can positively impact Nebraska's workforce, while also discussing key bills that focus on strengthening workforce like LB 1218 which incorporates LB 945, introduced by Sen. Linehan, and LB 902, introduced by Sen. Aguilar and prioritized by Speaker Hilgers. LB1218 was introduced and prioritized by the Education Committee.

WHEREAS, high state educational attainment is strongly correlated with higher state gross domestic product, higher per capita income, greater labor force participation, greater civic participation, improved health outcomes, and high quality of life; and

WHEREAS, projections are that at least seventy percent of Nebraska's jobs will soon require a degree, certificate, diploma, or other postsecondary or industry credential with economic value in the workforce; and

WHEREAS, Nebraska's current educational attainment, including degrees, certificates, diplomas, and other postsecondary and industry credentials with economic value is approximately fifty-eight percent for Nebraskans age 25 to 34, and approximately fifty-five percent for Nebraskans age 25 to 64; and

WHEREAS, Nebraska is in competition with other states and nations to develop, attract, and retain businesses and industries that require highly skilled employees and pay high wages; and

WHEREAS, most states, including neighboring states, have set ambitious educational attainment goals to reach social and economic development aspirations and use those educational attainment goals to inform education and workforce development policies; and

WHEREAS, state educational attainment goals can focus and organize a myriad of strategies related to workforce development and deployment, economic diversification and innovation, and promotion of diversity and inclusion; and WHEREAS, state educational attainment goals help state officials, colleges and universities, elementary and secondary schools, employers, and philanthropic and community organizations establish a shared agenda and measure progress at regular intervals; and

WHEREAS, a state educational attainment goal is in the spirit, and touches every aspect, of Nebraskans' aspirations for job growth, vibrant communities, attracting and retaining young people, income growth, and growth in innovation.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE ONE HUNDRED SEVENTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Legislature declares it is the goal of the State of Nebraska that at least seventy percent of 25 to 34 year-old Nebraskans have a degree, certificate, diploma, or other postsecondary or industry-recognized credential with economic value by 2030.
- 2. That the Legislature encourages the Board of Regents of the University of Nebraska, the Board of Trustees of the Nebraska State Colleges, the Board of Governors of each community college area, the

State Board of Education, and the Coordinating Commission for Postsecondary Education to adopt the seventy percent attainment goal as evidence of their support for such goal.

- 3. That the Legislature recognizes the strong contributions of Nebraska's private and parochial schools and independent colleges and universities to the educational attainment of Nebraskans and encourages their support of the seventy percent attainment goal.
- 4. That the Legislature finds that disparities in educational attainment impede individual and collective well-being and prosperity and must be reduced and eliminated to meet a seventy percent attainment goal.



- 5. That the Legislature declares that certain fields of study, including science, technology, engineering, manufacturing, agriculture, healthcare, and teaching, have particular strategic importance for the state's ongoing prosperity and encourages schools, colleges, universities, businesses, and community partners to join with the state to increase credential attainment in those fields.
- 6. That the Legislature encourages recent Nebraska high school graduates to continue their education in Nebraska postsecondary institutions and commends Nebraska postsecondary institutions for their efforts to enroll students from outside the state as a means of meeting the state's goal of growing a larger and more highly educated workforce.
- 7. That the Legislature encourages the Coordinating Commission for Postsecondary Education to incorporate the seventy percent attainment goal into the comprehensive statewide plan for postsecondary education required under Article VII, section 14, of the Constitution of the State of Nebraska and report on progress toward the goal in the annual report to the Legislature required by section 85-1429.

School board members are entrusted with a unique and formidable responsibility of providing sufficient opportunities and supporting educational achievement for all students. I will make myself available for any questions you might have, and keep you informed with updates of Board Candidate Webinars provided by the NASB and the New Board Member Workshop later this year. We invite you to attend our Regular Monthly Board Meetings which are held at the district office on the second Monday of each month starting at 7:00 p.m. Please review our website for more information. Once more, I can genuinely appreciate your decision and I thank you for your willingness to serve public education."

Foundation Boards – Schedule A (Form 990 or 990-EZ), Public Charity Status and Public Support. Form 990 is not complete without fully completing Parts I through XI and a proper signature in Part II, Signature Block. An officer of the organization must sign the return. This signature must come from the Superintendent if the foundation does not have a designated tax officer. Schedule B Parts I and II must also be completed if contributions totaling \$5,000 or more (in money or property) were recognized from any one contributor.

RELY ON NASB'S NATURAL GAS PROGRAMS





NASB's natural gas programs were created to fulfill two needs that many local districts had in dealing with utility costs – competitive prices and budget certainty. NASB has over 100 school districts and ESUs across Nebraska participating in our NJUMP and CJUMP purchasing consortiums to leverage their purchasing power and achieve lower utility bills. With this year's timely purchase of supplies at very competitive prices, we've continued to add new members for next year.

Superintendents and their business managers have their hands full with a huge range of responsibilities to oversee. Natural gas purchasing is one job your peers in these Interlocals can handle for you. Rather than pricing the entire year's gas needs on one day, the consortiums lock in fixed prices as market opportunities become available by purchasing in layers over time and in varying percentages of total projected volumes. Historically, this approach has achieved a better price for natural gas with a higher level of budget certainty than the districts could have achieved on their own.

The Nebraska Joint Utilities Management Program (NJUMP) purchases natural gas for school districts and ESUs on the Black Hills Energy natural gas pipeline in southeast Nebraska. Choice Joint Utilities Management Program (CJUMP) supplies natural gas on the Black Hills Energy (formerly SourceGas) distribution system in northern, central and western Nebraska. Both programs operate as independent Interlocal Pools created and governed by their own Board of Trustees drawn from consortium members. The trustees hold their annual meeting at the State Education Conference in Omaha each November.

Prior to her election to the State Board of Education in November 2020, Patti Gubbels served on the Norfolk Board of Education, and was a member of the NASB Board of Directors, and the NASB Legislation Committee since 2016.

In my last article, I indicated that the Nebraska State Board of Education would be voting at the March meeting on whether to adopt Ad Hoc Committee recommendations related to improving the standards development process. I noted in that article that one of the recommendations is to create a policy that directs the Board to adopt content areas standards for all subject matter areas.

At the March 4, 2022, Nebraska State Board of Education meeting, the Board adopted the following recommendations from the Ad Hoc Committee on Content Area Standards:

- The Executive Committee continue to review bylaw B2: Board Committees to improve the makeup and operation of standing committees, and recommend adoption of any revisions to the Board;
- The Executive Committee create a policy that defines the role of the Board in the development and revision of content area standards, and recommend adoption of the policy to the Board;
- The Planning and Evaluation Committee assume responsibility for guiding development, monitoring progress, and affirming revision of the NDE staff-managed content area standards development process;
- The Commissioner enlist the services of an external consultant to review and make recommendations to NDE staff to improve the content area standards development and revision processes; and
- The Executive Committee create a policy that directs the Board to approve content area standards for all subject matter areas and recommend adoption of the policy to the Board.

Because misinformation has been reported about what the recommendations mean, I thought it might be helpful to explain what the recommendation are and are NOT.

- The above recommendations apply to all content-area standards, not just health education.
- The Board has not taken any further action on these recommendations, other than adopting them. It will be up to the respective committees to determine next steps on each recommendation.
- The Board has not voted on health education standards.
- The Board has not voted to continue the process of developing health education standards.
- The board meeting agenda has not included an item to vote on reinitiating the process of developing health education standards.
- The only items that have been on the agenda (since September 3, 2021) specifically related to health education standards were brought forward from Mr. Penner at the February 4, 2022, meeting.
- There has never been an action item on a Board meeting agenda for the adoption of health education standards. The draft standards were released for public input and feedback in March 2021 and the process was postponed (as stated above) on September 3, 2021.

The overriding goal indicated in the Ad Hoc Committee recommendations is to improve the overall process for developing content area standards by the Nebraska Department of Education. I anticipate that, only after the standards development process has been improved and all the other approved recommendations have been implemented, will health education standards development be considered by the State Board of Education.

Having one vacancy on a board of six may seem unimportant, but if sudden accidents or illnesses should cause two more individuals to be temporarily absent, the board would be unable to create a quorum. A great deal of important board business is conducted in the spring and summer months, so it's critical that a board appoint someone to fill the remainder of the unexpired term. That process of filling a vacancy should be spelled out in your board policy.
